

## Regulations of the

"GOG's Made in Poland Sale x Nerds' Kitchen"

[referred to as the "Contest"]

### §1 GENERAL PROVISIONS

1. The Organizer of the Contest is Nerds' Kitchen [hereinafter referred to as the "Organizer"] in cooperation with GOG sp. Z oo, which is the Founder of the Awards in the Contest [hereinafter referred to as the "Founder"].
2. The Contest will be run and accessible via Facebook. The contest will be announced by publishing a post on the Nerds' Kitchen profile, available at <https://www.facebook.com/nerdskitchen/> [hereinafter referred to as the "Profile"].
3. Any natural person over 13 years of age may participate in the Contest, under the conditions specified in the Contest Regulations.
4. The Contest will be conducted all over the world, on the basis of these "Contest Regulations".
5. The Contest will start on November 9, 2021 at around 7:00 p.m. with the publication of the contest post via Facebook on the Organiser's profile, and will end on November 15, 2021 at 11:59 p.m. The results will be announced on November 21, 2021 at the latest.
6. Employees of the Organizer and Founder as well as other entities directly involved in the preparation and conduct of the Contest may not participate in the Contest.
7. Participation in the Contest is voluntary.

### §2 RULES OF PARTICIPATION IN THE Contest

1. A Contest participant may be any natural person over 13 years of age who has read the Regulations.
  - a) The prerequisite for participation in the Contest is the publication of an original answer to the question: "***Which dish or culinary element appearing in one of the games available as part of GOG's Made in Poland Sale is your favorite and why?***"
  - b) The answer to the Contest question should be posted in the form of a comment via Facebook, under the Contest post on the Nerds' Kitchen profile at <https://www.facebook.com/nerdskitchen/>
  - c) A contest participant may publish any number of entries (materials). All of them will be considered by the Jury separately. The prize will be awarded for one selected entry. One person may receive a maximum of one grand prize in the entire Contest.
  - d) Entries not related to the Contest Task will not take part in the Contest.
2. Entering the Contest is tantamount to a declaration that the Participant:
  - a) accepts the terms of the Contest Regulations. He agrees to the use of the submitted application for marketing purposes by the Organizer and the Founder.

- b) Consents to the processing of the following information contained in the personal profile on the Facebook.com website: name, surname for the purposes related to the Contest and awarding of prizes.
  - c) Is the author / author of the published works.
  - d) Consents to the free use - with the name of the author / author - by the Organizer and the Founder of the submitted materials at any time, in the form and in the media.
3. The submitted works may not violate generally accepted moral standards, in particular they may not contain content generally considered offensive and vulgar, expressions in the field of eroticism and / or pornography, racist materials promoting violence and / or violating the right to privacy, materials protected by exclusive rights (e.g. copyright) without the consent of their legal owners.
4. Contest participants are required to comply with these Contest Regulations. Any violations of the Contest Regulations may result in the Participant's exclusion from participation in the Contest.
5. The Contest is not subject to the provisions of the Gambling Act.

### **§3 LIABILITY OF THE ORGANIZER**

1. The Organizer is not responsible for:
  - a) The way in which the Website Users use the virtual space provided to them on the Website, or for any consequences resulting therefrom.
  - b) Damage caused by the content posted by participants on the Website.
  - c) Internet connections, in particular for interrupting, suspending or distorting such connection.
  - d) Loss or damage to content sent to the Website by electronic means.
  - e) Damage that may occur in the computer systems of the Website Users in connection with interactions with the Website.
  - f) Any problems related to the operation of Facebook.com.
2. All claims of the Website Users under the aforementioned titles are excluded from the Organizer's liability. The user agrees to release the Organizer from any third party claims arising in connection with the use of the Website by the user.

### **§4 AWARDS**

1. The winners will be selected by the Jury consisting of Anita Sarna, Karolina Krupecka from Nerds' Kitchen and Gabriela Siemienkiewicz, Zuzanna Grońska from GOG, on the basis of creativity and compliance of the Contest Application with the content of the Contest task. The decision is dictated by the subjective and unquestionable assessment of the Jury.
2. The three authors of the highest-rated materials will receive prizes in the form of a package of keys for 5 games (The Medium, Frostpunk: Game of the Year Edition, Papetura, Children of Morta, Banished), intended for the GOG platform, 1 package per 1 person.
3. A Participant who has received information about the selection of his Contest Application should report to the Organizer via a private message on Facebook in order to send access to the Prize.
4. Prizes will be supplied to those awarded by the jury through private messages on Facebook.
5. The results of the Contest will be announced by 21/11/2021 by midnight via a post on Facebook on the Organizer's profile.

6. It is not possible to exchange the prize for its cash equivalent.
7. It is not possible to transfer the rights to the prize to a person other than the Participant selected by the Jury.

## **§5 FINAL PROVISIONS**

1. Throughout the Contest, the Regulations will be available on the Organiser's website at <https://nerdskitchen.pl/en/contest-gog-made-in-poland-sale> .
2. The Organizer reserves that he is not responsible for: events preventing the proper conduct of the Contest, which he was unable to predict or which could not be prevented, in particular in the event of failure by the Participant to meet all the conditions for participation in the Contest or in the event of failure to deliver the prize to the Participant due to failure to provide or incorrect provision of data by the Participant.
3. The Organizer, in the event of non-compliance and breach by the Participant of the provisions of the Regulations, reserves the right to exclude the Participant from participation in the Contest, as well as to refuse to grant such a Participant a Prize.
4. The organizer of the Contest reserves the right to change the regulations and publish them to the public in the new version. The amendment to the Regulations will apply from the moment of its publication on the nerdskitchen.pl website.
5. Facebook.com provides only the infrastructure that enables the organization of the Contest. Facebook does NOT sponsor and does NOT participate in the organization of the Contest, and thus is NOT responsible for any actions of the Organizer and the consequences of conducting the Contest on the website.
6. In matters not covered by these Contest Regulations, the provisions of the Civil Code shall apply.

## **PRIVACY POLICY**

1. Nerds' Kitchen, being the Contest Organizer, does not process, share or use for marketing purposes the data provided by the Users of the website <https://www.facebook.com/nerdskitchen/> where the Contest is held.
2. Providing data by the winners is voluntary, but necessary for the purposes of the Contest - providing them is tantamount to consent to their processing only for the purposes of the Contest. They will be made available by the Organizer only to the Founder of the awards for the purpose of their shipment.
3. The collected data will be stored only for the duration of the Contest until the winners are selected and the prizes are handed over.
4. The use of data of users participating in the Contest is specified in the Contest Regulations.
5. The participant has the right to withdraw consent, rectify and delete data, as well as submit a complaint to the supervisory body.
